Terms and Conditions of Loan Agreement

1. The company or person receiving this loan must supply U-Touch with credit or debit card details to be on company file for the length of the loan (to be used if your terms of the agreement are not fulfilled).
2. Equipment must not be moved from the location shown below without U-Touch's prior consent. The loan period and term of this contract shall commence on the loan start date and should not exceed the below loan finish date except with U-Touch's consent.
3. Equipment is to be used for demonstration purposes only in accordance with U-Touch's user instructions.
4. Equipment must not be altered or interfered with in anyway. UT trademarks must not be defaced or amended in any way.
5. Equipment is not to be demonstrated at the same time as similar and competing equipment without U-Touch's prior written consent.
6. Equipment remains the exclusive property of UT throughout the loan. Equipment must be kept distinguishable from other goods. The customer is obliged to assert U-Touch's right to the equipment within office hours. The customer shall prevent the equipment becoming subject to any change or encumbrance.
7. U-Touch may inspect the equipment at any time upon reasonable notice to the customer. UT may terminate the loan at any time at their discretion and may enter the customer's premises by prior arrangement with the customer to remove the equipment or require its return to UT.
8. The customer signed to this document must arrange and pay for the shipping of the goods for the loan - both to and from U-Touch.
9. The customer shall be exclusively liable for the full current market value of the equipment in the event of any loss or damage to the equipment arising from its use by the customer. Any loss or damage to the equipment must be reported as soon as practicable.
10. UT shall not be liable for any loss or damage however caused by the equipment including any consequential loss or loss of profit whatsoever save that UT shall be liable for death or personal injury caused by U-Touch's proven negligence. No warranties are given in respect of the equipment as demonstration stock, except that UT warrants that it is entitled to provide the equipment complies with all applicable health and safety regulations.
11. The loan agreement is personal to the customer and cannot be assigned or transferred by either party.
12. A copy of this loan agreement must be kept at the location shown below throughout the period of the agreement.
13. This loan agreement is subject to English Law and the parties consent to the jurisdiction of the English courts.
